

ENFORCEMENT

- Criminal Action: Initiate filing of criminal actions before court for search and seizure of infringing and counterfeit goods available in the market.

In order to prohibit import of the counterfeit and infringing goods it is imperative that IP holder registers itself before the Custom Authorities.
